On behalf of the National League of POW/MIA Families, I am writing to convey our full support for your initiative to amend Title 10 of the United States Code to provide Full Military Honors for enlisted returned Prisoners of War (POW) and Medal of Honor recipients.

Since formed on May 28, 1970, the League's sole purpose beyond working to improve treatment of those captured has been to obtain the release of all POWs, the fullest possible accounting for the MIAs, and repatriation of all recoverable remains of those who died serving our country during the Vietnam War.

We were truly surprised to learn that enlisted returned POWs are not extended the courtesy of a Full Military Honors ceremony at Arlington National Cemetery. It is unthinkable to fail to extend such honors to all those who served with bravery and dignity while in captivity. They certainly faced no less hardship than their fellow POW officers.

Please keep us informed as to anything we can do to provide further assistance to ensure that your intended legislation obtains the requisite support to move this forward.

On behalf of President Rick Estes of the Special Operations Association, President Gary Koenitzer of the Special Forces Association and our 13,000+ members, I am writing to express the full support of both our associations for your initiative to amend Title 10 of the United States Code to authorize Full Military Honors for military funerals honoring enlisted Medal of Honor recipients and returned Prisoners of War.

While it is understandable that senior noncommissioned officers (E-9) and officers are afforded Full Military Honors based on the level of their contributions and responsibilities, we feel strongly that the full measure of devotion exhibited by enlisted personnel who earned the Medal of Honor or served honorably as Prisoners of War likewise is deserving of more than Standard Honors. Rank should not be the sole determinant of who has earned our nation's highest expression of gratitude.
